MINUTES January 12, 2023

Item 1: Meeting Called to Order by Mayor Roberts.

City Clerk Karen Jordan administered the Oath of Office to Newly Elected Council Members Scott Barnes, Vicki Benefield, and Annette Homiller. Each will serve a four-year term.

c) Reaffirm Check Signers for any/all banking/checking accounts.

Council Member Benefield put forth a motion, Seconded by Council Member Barnes to appoint Mayor Roberts, City Clerk Karen Jordan, City Manager Eric Wilmarth, and Police Chief Bryon Reeves to sign any and all checks \$500.00 and over for any and all City banking/checking accounts. Motion Unanimously Approved

d) Consider Establishing and Fixing Qualifying Fees for Municipal Elections per O.C.G.A. §21-2-131(1)(a)

Council Member Benefield put forth a motion, Seconded by Council Member Barnes to establish a qualifying fee of \$108.00 for the Office of Mayor and \$35.00 for the Office of Council Member. Motion Unanimously Approved.

e) Consider Arbor Day Proclamation

Council Member Nelson put forth a motion, Seconded by Council Member Homiller proclaiming Friday, February 17, 2023 as Arbor Day in the City of Ball Ground.

Motion Unanimously Approved.

Mayor Roberts said tree planting would take place on Friday, February 17, 2023 at a place and time to be determined. Mayor Roberts also noted that Ball Ground was first designated as a Tree City in 1989 and was the first city in the county to achieve this honor.

f) Consider GMA Lease Purchase Hydro Vac Excavator

City Manager Wilmarth requested authorization to enter into a Georgia Municipal Association Lease Purchase Agreement to obtain a CV SGT Vacuum Excavator by Vermeer. Recently there have been incidents where having this equipment would have been most beneficial. It is anticipated that the formal quote would be around \$70,000.00. The lease purchase agreement would have a 3.97% interest rate with monthly payments estimated at \$1,466.77.

Council Member Nelson put forth a motion, Seconded by Council Member Barnes to enter into a lease purchase agreement through the Georgia Municipal Association to purchase the Hydro Vac Excavator.

Motion Unanimously Approved.

g) Consider Updated Intergovernmental Agreement for Cherokee County to Conduct Elections for the City of Ball Ground.

Council Member Rogers put forth a motion, Seconded by Council Member Nelson to enter into a Intergovernmental Agreement with Cherokee County for the purpose of the Cherokee County Board of Elections and Registration with regard to the preparation for, conduction and administration of primaries and elections, succeed to and exercise all duties and powers granted to and incumbent upon the election superintendent pursuant to Title 21 of the O.C.G.A.

Motion Unanimously Approved.

Item 9: City Manager Comments

City Manager Wilmarth provided Council Members with an unaudited report of account balances, and statement of revenues and expenditures for the month ended December 31, 2022. The report showed cash on deposit totaled \$2,815,178.43.

City Manager Wilmarth provided updates on several city projects.

Chief Reeves provided Mayor Roberts and Council Members with a written report of the Police Departments monthly activity for period ended December 31, 2022.
