TYPES OF PROJECTS REQUIRING A BUILDING PERMIT

Building Permits ARE Required for:

- 1) New Construction
- 2) Additions (Including patios, decks, porches)
- 3) Renovation Work (Including new doors, windows, remodel involving electrical, plumbing, roofing and roofing repairs, hot water heaters, changes to any load bearing walls)
 - a) Permits are only required when changing out 50% or more of a combination of doors and windows.
- 4) Outbuildings over 200 sf

Building Permits ARE NOT Required for:

- 1) Painting
- 2) Counter Tops
- 3) Wall Papering
- 4) Storage Sheds Under 200 sf
- 5) Tile
- 6) Fences Under 7' Tall
- 7) Carpeting
- 8) Retaining Walls Under 3' Tall
- 9) Cabinets

Fee Schedule

- 1) All fees are based on the City of Ball Ground Fee Schedule

INSPECTIONS

Builders requesting an inspection should contact the City Hall at 770-735-2123. Every attempt will be made to provide a next day inspection service for all requests received prior to 2:00 p.m.

Required Inspections:

- Temp Power (if used)
- Temp to Perm Power (if used)
- Silt Fence and clearing
- Footing
- Wall (over 3')
- In slab plumbing (if present)
- Slab
- Rough-In (Framing, Mechanical, Electrical, Plumbing)
- Final (Includes landscape, tree replacement and sidewalk where required)
- Every site visit will include a silt and sediment control observation

OWNER BUILDING PERMIT AFFIDAVIT

The undersigned hereby applies for special consideration as a property owner desiring to perform construction or serve as general contractor for his or her own residence. In making this request for an owner/builder permit, the undersigned states the following to be true:

- *Applicant owns the property, intends to occupy the structure, and is not for use by the public and not offered for sale or lease.*
- *Applicant shall serve as the general contractor and accept inherent responsibilities for the work authorized by the approved permit in accordance with Georgia’s licensing law pertaining to Residential and General Contractors.*
- *If applicant is not installing the electrical, plumbing, or mechanical as building owner, he/she agrees to hire properly licensed electrical, plumbing, and mechanical contractors. As general contractor, applicant may contract with traditional specialty contractors or limited-service specialty contractors who are not required to hold a license as a residential or general contractor if performing within their specialty as provided for under O.C.G.A. 43-41-7. Applicant may not hire another individual to hire sub-contractors without that person being licensed as required by the State.*
- *Should applicant sell the home/building within 24 months following issuance of the certificate of occupancy; applicant understands he/she will not be allowed to permit another home/building unless applicant is duly licensed by the State of GA.*
- *Applicant agrees to build in accordance with applicable codes and strictly adhere to the inspections as required by the jurisdiction. Undersigned acknowledges that inspections must be performed in an established sequence as required by the jurisdiction and that work done in violation of the building codes must be corrected or may be ordered removed.*
- *Applicant acknowledges that he/she is aware that a permit issued under the provisions of the code may be revoked for false statements of misrepresentations as to the material fact in the application on which the permit was based.*
- *Applicant acknowledges that making false statements made in the permit application will subject said applicant to possible prosecution and/or fine. Georgia Criminal Code, Article 2, Section 16-10-20 (False Swearing) calls for a possible fine of not more than \$1000.00 or imprisonment for not less than one (1) nor more than five (5) years or both*

HOUSE LOCATION PLAN

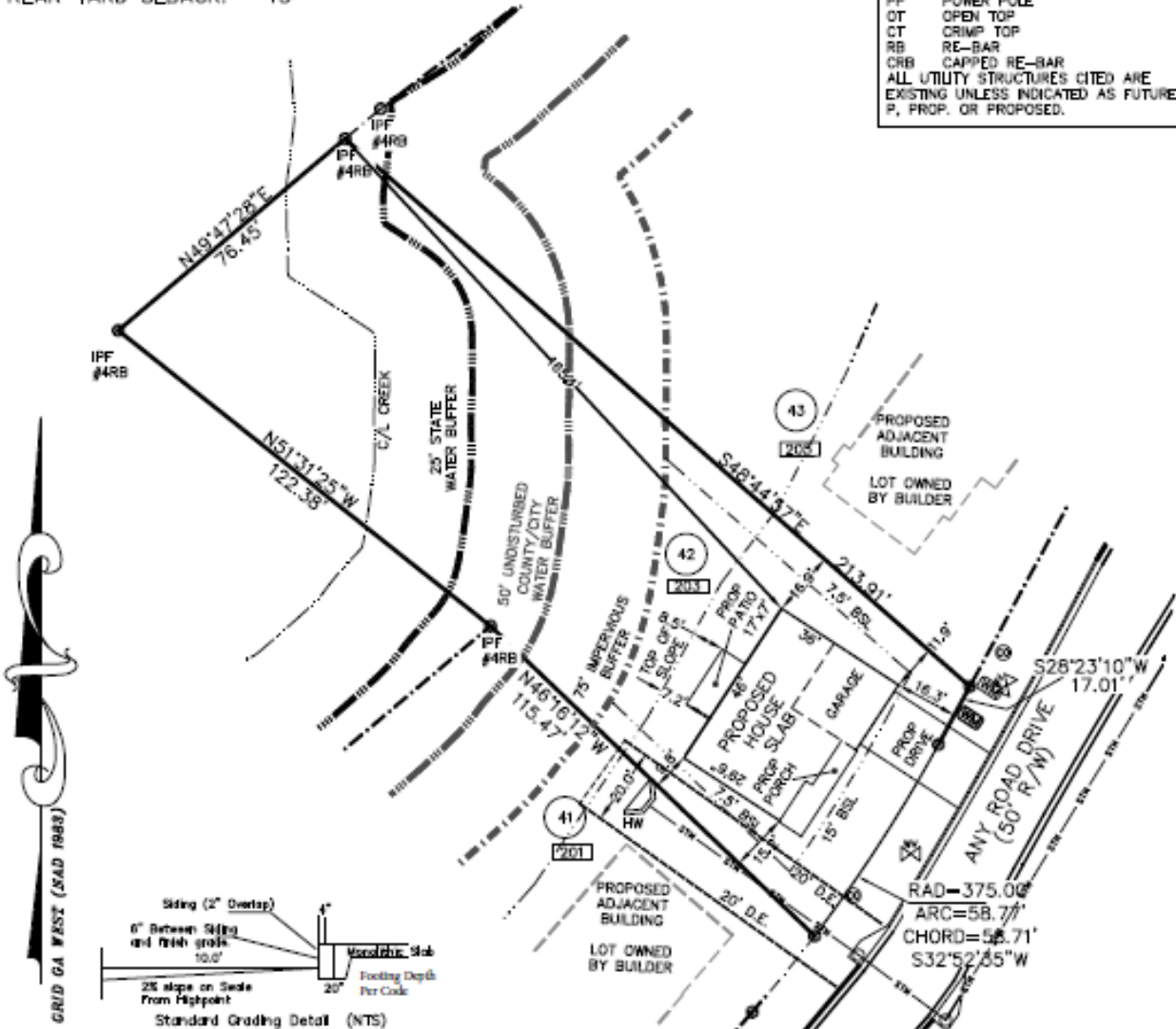

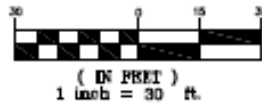
