Item 1: Meeting Called to Order by Mayor Rick Roberts.

Item 2: Pledge of Allegiance Led by Mr. Bob Wood, Veteran of the month.

Item 3: Approve Agenda

Council Member Rogers put forward a motion, Seconded by Council Member Barns to approve the agenda with the exception to remove Item 8(b) Consider AN ORDINANCE AMENDING AND RESTATING SUBPART A-GENERAL ORDINANCES; CHAPTER 22-SOLID WASTE; ARTICLE II-COLLECTION AND DISPOSAL; DIVISION 2-NONCOMMERCIAL SOLID WASTE; SECTION 22-34- PLACEMENT OF WASTE CONTAINERS FOR PICKUP from the agenda.

Council Member Rogers put forward a motion, Seconded by Council Member Benefield, to approve the minutes of the April 4, 2024 meeting as submitted in writing by the City Clerk.

b) Consider Second Reading of 2023-2024 FY Operating Budget

Mayor Roberts noted that the budget had been properly advertised, and a public hearing was held prior to tonight's meeting, with only staff in attendance. No public comments received.

Council Member Rogers put forth a motion, Seconded by Council Member Barnes, to approve the FY 2024-2025 Operating Budget as submitted.

Motion Unanimously Approved.

Item 8: New Business

a) Consider Appointment to represent Ball Ground on the Sequoyah Regional Library System

Mayor Roberts stated the term of Vivian Murphy will expire on June 30, 2024 and she did not wish to be reappointed for a second term. He had spoken with Stephanie Joyner, and she has agreed to serve as the Ball Ground representative. Ms. Joyner's term will end on June 30, 2027.

Council Member Homiller put forward a motion, Seconded by Council Member Nelson to approve the appointment of Stephanie Joyner as the new Ball Ground representative on the Sequoyah Regional Library Bord beginning July 1, 2024 and ending June 30, 2027.

Motion Unanimously Approved.,

- c) Consider Adoption of Parks Master Plan

Mayor Roberts asked Chris Luly to provide an overview of the process to develop the Parks Master Plan.

Chris stated feedback was received from meetings with the various groups that utilize the athletic facilities. Two open houses were also held where residents could view the proposed plan. An online survey was also conducted where an overwhelming number of residents responded. All the information was then compiled into the document to be considered this evening.

Mayor Roberts thanked Chris for his endeavor in formulating a plan that will enhance the use and beauty of Calvin Farmer Park today and for years to come.

Council Member Benefield put forward a motion, Seconded by Council Member Barnes to approve the Parks Master Plan as submitted by Chris Luly, Director of Planning and Zoning.

Motion Unanimously Approved.

d) Consider 3-Way Stop at Groover St. and Civic Drive

Chris Luly explained the situation of traffic flow on Civic and Groover Streets since Groover has been extended to access new development. Cars traveling the extension of Groover go straight while cars traveling Civic also go straight creating an intersection with no signage signaling anyone to yield to on coming traffic.

Council Member Benefield put forth a motion, Seconded by Council Member Barnes to amend the item of business to consider a four-way stop at Groover St. and Civic Drive rather than the three-was stop as proposed.

Motion Unanimously Approved.

After further discussion Council Member Homiller put forth a motion, Seconded by Council Member Barnes to create a four-way stop intersection where Groover St. intersects with Civic Drive.

Motion Unanimously Approved.

e) Consider Property Lease Agreement with Patriot Rail

Mayor Roberts stated the negotiations with Patriot Rail are ongoing and asked that the council consider tabling this item of business for sixty days.

Council Member Nelson put forward a motion, Seconded by Council Member Rogers, to table this item of business for sixty days.

Motion Unanimously Approved.

f) Consider First Reading of Request of Farm Winery License/Wine Consumption on Premises

Business: 1984 Brewing LLC/DBA Rock Solid Brewing Co.

Applicant: Christina Lauer Location: 345 Gilmer Ferry Rd.

Council Member Benefield put forward a motion, Seconded by Council Member Barnes to approve the first reading of the request for a Farm Winery License for consumption of wine only on premises with the following condition:

Applicant Christins Lauer agrees not to submit application for a license to operate a distillery or a license for distilled spirits by the drink for consumption on premises.

Motion Unanimously Approved.

The second reading of this application will be heard at the June 13, 2024 City Council meeting.

Item 9: City Manager Comments

Chief Gianfala presented the council with a monthly report of the department's activity. He also reported on the status of completing the process to achieve State Certification. Chief Gianfala stated he is optimistic the department will achieve this goal within the next six to nine months.
